

# **Boomerang Terms of Service**

How Boomerang governs your use of the service.

#### Introduction

Please read these Terms of Service ("Terms", "ToS") which include the Privacy Policy located at <a href="mailto:bmrq.app/privacy">bmrq.app/privacy</a> before accessing Boomerang's services ("us", "we", "our", "Boomerang"). These services include but are not limited to the use of our website and any subsequent domains or subdomains, conjointly referred to as the "website" or the "site", the Boomerang Discord Bot ("the bot", "bot") and our API ("Application Programming Interface", "API"). The site, bot and API are collectively known as the "service" or "services". The services may expand at any time with or without prior notice at the sole discretion of Boomerang's management team.

By accessing Boomerang's services, you agree to be bound by these Terms of Service. It is your responsibility to comply with any applicable local laws. These terms apply to all visitors, users, and others using Boomerang. We may modify these terms at any time, with or without notice. If you disagree with <u>any</u> part of these terms, do not use our services.

#### **Access to the Service**

Boomerang reserves the right to suspend or terminate access to Boomerang services immediately, with or without prior notice, for any reason whatsoever. In the event that you are suspended or terminated from the service, you may not attempt to use the service in any other way. The suspension or deletion of your account(s) do not entitle you to claims of compensation, damages or reimbursement. We operate on a strict no-refund policy.

- Boomerang is not to be used by anyone under the age of 13
- Boomerang is not to be used for any purposes that are not in accordance with the law
- You are not to impersonate Boomerang or Boomerang Staff
- You are not to spam the service in an attempt to negatively affect it
- You are not to cause harm to the service in any way, shape or form
- You are not to spread misinformation or unconfirmed rumours about the service or staff
- Do not use Boomerang to, or in association, violate <u>Discord Terms of Service</u>
- Do not use automated tools or scripts to access or exploit Boomerang services

#### **Data Collection**

Boomerang may collect your public user information for functionality reasons. This data includes but is not limited to your username, avatar, account ID, and guilds you are a member of. Additionally, Boomerang may also collect data for plugins/features of the service. Access can be revoked at any time through the "Authorised Apps" setting of your Discord account. To request all data related to your account be deleted, please email us via <a href="mailto:legal@bmrg.app">legal@bmrg.app</a>. Under no circumstances will we delete infraction data solely at the user's request, as this data is retained for legal and operational purposes. The data collected for this plugin is public and non-sensitive.

## **Acceptable Use**

Users are responsible for making sure their use of Boomerang services violate no applicable law, regulations, or third-party rights. Therefore, we reserve the right to take any appropriate measure to protect our legitimate interests, including denying users access to the service or reporting users for abuse or misconduct to the appropriate authorities - such as judicial or administrative authorities - whenever users are suspected to be in violation of any laws, regulations or third-party terms.

Throughout our services, you may be redirected to or provided with resources owned and/or operated by third parties. We do not have any control over such resources and therefore are not liable for such resources. Further, we do not have control over the content and availability of such resources.

## **API Usage**

Users are permitted access to data relevant to either their account or the service via the Application Program Interface (API). Although Boomerang reserves the right to modify API terms without notice, we aim to inform users of significant changes through relevant channels where possible.

## **Payments**

Boomerang is a paid service available for a fixed price of \$15 AUD. We currently accept one payment method for purchasing access, which is subject to change without prior notice. The Core Team reserves the right to modify payment methods and pricing at any time, including the introduction of alternative payment options not listed herein.

All purchases made through Boomerang are processed via Stripe. Please note that all sales are final, and refunds will not be provided under any circumstances.

#### **Privacy Considerations**

We recommend reading <u>Stripe's Privacy Policy</u> before making a purchase with your relevant currency to fully understand how your data is handled.

#### **Purchase Information**

When making a purchase, you may need to provide certain details such as your credit card number, expiration date, holder name, CVC, billing address, full legal name, phone number, and email. As mentioned earlier, we use Stripe for payment processing, and by submitting your information, you grant us the right to provide this information to Stripe in accordance with our privacy policy.

#### **Payment Refusal or Cancellation**

We reserve the right to refuse or cancel your payment/order at any time. This may occur due to product or service availability, errors in product descriptions or pricing, errors in your order, or other reasons. If a product is mispriced and you've purchased it at the incorrect price using Stripe, we will reject your order and may refund the purchase amount. Additionally, we retain the right to refuse or cancel orders in cases of suspected fraud or unauthorised/illegal transactions.

Each party shall bear its own costs related to the mediation and arbitration process, and the costs of the mediator and arbitrator shall be shared equally unless otherwise determined by the arbitrator.

## **Governing Law**

These terms shall be governed by and construed in accordance with the laws of the state of Victoria, Australia. Any legal action or proceeding arising out of or related to these terms shall be brought exclusively in the state or federal courts located within Victoria, and you consent to the jurisdiction of such courts for any such action or proceeding.

## **Software Access and Longevity**

Users who acquire a slot, granting access to Boomerang, must comply with the ensuing terms, designed to prevent resale or unauthorised third-party distribution channels.

- **Transferability:** Transfers of slots to other users are at the sole discretion of the Core Team.

  Users who wish to transfer their slot must contact ModMail, and by transferring, forfeit all rights and privileges to access said slot.
- **Prohibition of Resale or Lease:** Users are prohibited from engaging in the resale or lease of their slot to any third party. This includes but is not limited to offering access to Boomerang in exchange for monetary payment, subscription fees, or any other form of compensation.

Further, Boomerang operates on the principle that slots are purchased for the lifetime of the bot rather than the individual user. This means that while users acquire access slots, they are tied to the ongoing operation of the Boomerang service itself.
